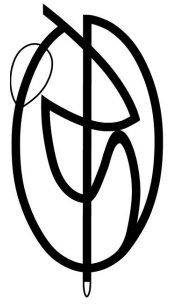

Shooting Times Both Days: Practice commences 08.30am. Shooting commences 09.30am

Practice: There will be 45 minutes practice each day before shooting commences. Equipment inspection will be conducted during practice.

Shooting: To be shot in accordance with the FITA Rules of Shooting. Arrows will be shot in ends of 6 in 4 minutes and 3 in 2 minutes.

Round: Saturday - Two FITA 70m Rounds. Sunday - FITA 70m Olympic Head to Head.

Drug Testing: Record status tournaments are liable for drug testing and any competitors approached to give samples must comply; if they refuse that refusal will be treated as a positive result. Where an entry form contains one or more junior entries, the parent or legal guardian must countersign the form to signify they consent to their child(ren) being tested.

Divisions: Mens and Ladies Recurve and Compound

Dress: GNAS dress regulations (Rule 307) apply and will be enforced.

Entries: £12.00 per day, £22 for 2 day entry. **Cheques made payable to "Rivernook Bowmen."**
